

Privacy Policy

At **Nu-Rejime & CallTheBizPro.Biz** (“Company”), we respect the privacy of our readers and Customers/Members. We are gravely concerned about practices which violate the basic rights of choice and confidentiality.

Here is our covenant with the readers who trust us with their personal information.

We Promise:

1. **Any e-mail you give us is safe.** We store your data in databases that only the staff of Company have access to. No one besides us will ever get access to your e-mail address.
2. **Third Party Use.** We’ll never sell you. We never rent out or sell our subscriber lists to third parties like other companies might. So you’ll never receive junk mail or anything from any third-party by entering your details into any of our forms. We do use highly credible services that provide automated systems that we utilize to communicate through email with you. We have had, in most cases, very longstanding, over 15 years, relationships with these providers and know them to be of the same mind as we are when it comes to your privacy needs. We do use WooCommerce as our store ecommerce solution. WooCommerce does receive code metadata to determine “only” how effective their code is operating on our site. Your *private information* is never shared with them. The only company that receives your contact information and credit card data is Stripe who we use to process credit cards. 3. **Easy “one-click” unsubscribe.** If you want to get off our list permanently, there’s an “unsubscribe” link in every one of our outgoing e-mails. Just click it and you’re instantly off the list — that means you’ll never receive another e-mail from us (unless you specifically ask to, of course). We use Aweber Email Marketing to house and email our Customer/Members information the Company deems necessary for our Customer/Members to be aware of.

The remainder of this Privacy Policy will let you know what kind of information we collect on the website at CallTheBizPro.Biz (the “Site”), how it is handled, with whom it may be shared, what choices you have regarding our use of your information and how you may access some of the data you provide to us.

PERSONALLY IDENTIFIABLE INFORMATION
